



International Student Supplementary Form to the Offer of Admission

All international students must ensure that they have a Student Authorization permit from Citizenship and Immigration Canada in order to study in Canada. It is not possible to change from visitor to student status within Canada. The following information is provided at the request of Citizenship and Immigration Canada. Please submit this document and the Offer of Admission with your application for student authorization.

Duration of MMPA Program

There are three different streams in the MMPA Program and therefore different starting dates and program lengths depending upon the student's level of course advanced standing. The convocation ceremony normally takes place in November following the student's final summer term. The Student Authorization permit should extend to the end of November in the year of graduation so that students are able to attend their convocation ceremony.

- It is 27 months in length for students beginning in May in the two session program. The Program will begin approximately May 24th 2016 and the convocation ceremony will be in November 2018 for these students.
- ♦ It is 24 months in length for students beginning in September in the two session program. The Program will begin on approximately August 22nd 2016 and the convocation ceremony will be in November 2018 for these students.
- It is 12 months in length for students beginning in September in the one session program. The Program will begin on August 22nd 2016 and the convocation ceremony will be in November 2017 for these students.

Expenses for International Students

The expenses listed below are for a 12-month period. The tuition, incidental and ancillary, and UHIP fees are annual fees and are due before registering in the first term each year. However, students may pay a minimum of 50% of the tuition, incidental and ancillary fees in the first term and the remaining 50% before beginning the second term. There will be a service charge levied on the outstanding 50% balance starting in the second term until it is paid in full. Enrollment in the University Health Insurance Plan (UHIP) is mandatory for international students registered at the University of Toronto and the total fee is due before registering for the first academic term.

Earning Potential

The MMPA Program is a co-op program and therefore has a mandatory co-op work term each year in a business environment. Students may earn on average \$13,500 during each work term.

Co-Op Work Permit Requirement

Students must have a valid Co-op Work Permit in order to complete the work terms. Students in the 27 and 24 month streams will have two work terms and students in the 12 month stream will have one work term. Each work term is 4 months and will run from January to April inclusive each year. Students will not be eligible for graduation if these work terms are not completed satisfactorily.
